The 2011 Border Ranges Rally will continue the tradition of Rallying on shire roads in the beautiful NSW valley of URBENVILLE and WOODENBONG. This year the Gold Coast Tweed Motorsporting Club Inc. will be conducting the competition on Saturday 9th April, centered at new facilities at the Woodenbong Showground. For those of you who want a great day's rallying, including a short bitumen/gravel stage at night (run several times), try our club's proven formula, and join us in the Northern Rivers District of NSW. The Border Ranges Rally is the first round of the 2011 Queensland Rally Championship but is also open to most rally competitors and should provide some great competition. Two levels of entry fee are available. The event will follow a similar format to previous years with good quality shire roads. We are again aiming to finish the event early, to provide ample opportunity for competitors to socialise during the presentation at the Woodenbong Showground following the event. Please be advised that there are great camping facilities on the Woodenbong Showground perimeter, and that hotel/motel accommodation is available in Woodenbong and Urbenville. The traditional morning after breakfast, with excellent catering by the local community, will again be available at Woodenbong Showground, so we invite you to stay overnight and enjoy the festivities. Finally, if you are not planning on competing you might like to consider helping at the 2011 event. Ari Vatanen

With an attacking driving style, Ari Vatanen was the poster boy for rally fans in the 1970's and 1980's, always bringing a sense of speed and danger to the sport.

Ari Pieti Uolevi Vatanen was born on 27th of April 1952 in Tuupovaara, Finland and began his rally career at just 18. He acquired an Opel Ascona and by 1974, optimistically entered the 1000 Lakes Rally where he promptly retired after loosing a wheel. He then brought the Opel to Britain where he impressed many with his natural speed leading to an



offer to drive a Ford Escort, however there were no results in the two years that followed. Even a full



season in 1977 only netted him a second place in New Zealand and third in the European Championship (and most of the retirements were self inflicted).

When Vatanen did stay on the road, he was a joy to behold, drifting the Escort around like it was on rails. In 1979, David Richards joined him as co-driver and in 1980

he won the Acropolis Rally at only his second attempt.

Unfortunately, Ford then pulled out of rallying and Vatanen was forced to run in David Sutton's private team. In 1981, after a year of considerable drama & success, Vatanen won the World Drivers' Title, winning three of the seasons 12 events (Acropolis Rally, Rally of Brazil & the 1000 Lakes Rally) plus two podium places, winning the title on 96 points, just 7 points ahead of Guy Fréquelin & co-driver Jean Todt in a Talbot Sunbeam Lotus.

In 1982, he did two WRC events with Ford but then signed for the Rothmans Opel Team in time for the RAC Rally and drove the Opel throughout the next season. At only his second appearance on

the 1983 Safari Rally, he won, driving a Ascona 400. The new Manta 400 was not so kind and at the end of the year he was approached by Peugeot to drive its new Group B rally car for 1984. He had to wait till Corsica to take the 205 T16 on it's first WRC outing where both he and the new car impressed,

leading before retirement.

Vatanen then went on to a run of success winning 5 WRC events in a row (starting in Finland in 84 & finished with victory in Sweden in 85). He rolled on the RAC, checked in four minutes early on the Monte, but both times fought his way back to take victory.

After suffering a bout of mechanical failures, he went to Argentina and had a horrific high speed accident. For weeks it was thought that he may not survive, then months that he might not recover. But after just over 12 months later, Vatanen was behind the wheel of a Peugeot and winning, the only difference was that Peugeot had pulled out of the WRC and this was the Paris Dakar of 1987. Vatanen went on to win the desert event three more times, along with the Pikes Peak hill climb.

At the end of the 80's and into the 90's, Vatanen drove for Mitsubishi, Subaru and finally back at Ford. He also stood in at short notice for an injured Bruno Thiry on the 1998 Safari and would have been second if he had not yielded the place to team mate, Juha Kankkunen. His last factory drive was for Subaru in 1998, his 100th WRC start, but he has also entered Rally Finland in 2003 driving a Peugeot 206 WRC finishing an impressive 11th, waving to fans as he drove.



Vatanen may best be remembered for his amazing drive in the Peugeot 405 T16 at Pikes Peak in the USA which was captured in the amazing 'Climb Dance' film. If you haven't seen the video check it out at:
